Eligibility Criteria for Bidder	Supporting Documents Required
Bidder should have a valid insurance license to provide requisite insurance and claims settlement services in India with the requisite documentation from the regulator in that regard in their possession. The license should be valid for the policy servicing period.	Copy of license issued by IRDAI to be submitted
Bidder should be a Government organization / PSU or a registered/ incorporated company in India under the Companies Act 1956/2013 and having business in India during last 5 years.	Copy of certificate of incorporation to be submitted
The Bidder should have market share of 2% or more and have Gross Written premium of INR 3,000 Cr & above in the General Insurance Industry as on 31 March 2025. This must be the individual company turnover and not that of any group of companies	Audited Financial Statements for the financial years 2024-25 to be submitted OR Certified letter from the Chartered Accountant. The CA certificate in this regard should be without any riders or qualification.
The bidder/ Insurance companies should have served at least 1 PSB (nationalized bank) / RRB / Private Sector Banks having pan India branch network of more than 500 branches, covering Safe Deposit Locker Policies for the Banks, during any of the last three fiscal i.e., 2023-24, 2024-25 & for current financial year 2025-26.	A self-attested declaration providing the name of the bank or policy cover page shall be submitted in support of the experience in the BI policy binding for the bank





**Confidentiality** - Bidder must keep confidential, any information received from or about TAMIL NADU GRAMA BANK as a result of or in connection with the submission of the Response. All information contained in the Response, or in subsequent communications shall be deemed confidential and may be used only in connection with the preparation of Bidder's Response.
